Decision with reasons:-


1. In the appeal, the appellant has stated that he has received no information on his appeal filed against the DGIT, Income Tax. Regarding the registration of cases involving DGIT, Income Tax, Dak Section of this Commission has intimated that the case has been registered as CIC/BS/A/2015/002222. **Direction is accordingly given to Shri R.L. Gupta, DO to IC(BS) to provide the present status of this appeal to the appellant within 1 week from the date of receipt of the order.**
2. Regarding the appeal against RBI & SEBI, the CPIO and DO to IC(MP), Shri T.K. Mohapatra has intimated that both the cases against RBI and SEBI has already been heard and disposed of by the bench of IC(MP).
3. It has been observed in the RTI file that the RTI was forwarded to CR Section by RTI Cell but instead of replying to the RTI application, Shri U.C. Joshi, DR to CR has simply transferred the RTI application to the Dak Section. The information on the status of any of the dak is available in the RTI-Admin and also in the CIC's website, hence, Shri Joshi should have taken the information from there and provide information on the action taken on the particular letter to the appellant instead of transferring to the Dak Section because of which the appellant has not received the information in time. **Shri U.C. Joshi, DR to CR & CPIO is advised to be more careful, in future, while dealing with the RTI applications so that the appellant may receive the information in time and the appellant will not require to file first appeal for not getting the information.**
4. The appeal is disposed of accordingly.
