Decision with reasons:-

- 1. As per first appeal, the appellant is aggrieved only with the response given on Points 5, 6, 7 and 10 of the RTI application. On Point 5, CPIO & DR to CR has intimated the appellant that the receipt management system does not indicate any status of the appeal as stated and requested the appellant to intimate the date of the second appeal. The appellant has provided photocopy of the said second appeal as Annexure 'B' along with the first appeal. Direction is given to Shri U.C. Joshi, CPIO, CR Section to provide the information to the appellant within 1 week from the date of receipt of the order. Annexure 'B' as provided by the appellant is enclosed.
- 2. On Point 6, the DR to CR has intimated that status of Dy.No.155170/20.08.15 is not currently available and efforts are being taken to trace out and requested the appellant to send copy of the same to take further necessary action to avoid further delay. The appellant has mentioned in the appeal that he has enclosed a copy of second appeal as Annexure-3 but no such enclosure is found enclosed with the appeal. The appellant is advised to send a copy of the same to the DR in Central Registry.

- 3. On Point 7, the DR to CR has informed the appellant that receipt management system do not indicate any status of the appeal as stated and asked the appellant to intimate the exact date of the second appeal to enable him to locate it. The appellant has stated in the appeal that he has no exact date. Therefore, no further direction can be given to the CPIO.
- 4. On Point 10, DR to CR has replied that the appeal dated 20.05.16 (Dy. No.140309/2016) has been returned due to deficiencies in documents. The appellant in the appeal has stated that this information is incorrect, because no appeal from CIC was returned and received by him and asked to attach the proper evidence of returning of his appeal. CPIO, CR Section, Shri U.C. Joshi is directed to send a copy of the defect memo along with dispatch proof to the appellant within 1 week from the receipt of the order.
- 5. The appeal is disposed off.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
