Decision with reasons:-

1. In the RTI application, the appellant has sought information and a copy of the judgment passed on his second appeal dated 01.01.2015 having Diary No.103129/2015 and also complete file notesheets. The CPIO, Shri U.C. Joshi, DR to CR has replied as under:-

"No record for the information sought is available".

- 2. In the appeal, the appellant has stated that the information provided by the CPIO is not correct as the appellant mentioned that he has received a letter dated 05.03.2016 from CIC for necessary compliance and he has already completed and submitted to the Commission.
- 3. Since the appellant has mentioned the diary number, the CPIO, Shri U.C. Joshi should have made efforts to find out the action taken on that diary number but the CPIO has mentioned that no record is available. The reply of the CPIO is not appropriate and justified. Because of the non furnishing of proper reply by the CPIO, the appellant has unnecessarily filed the first appeal which may not be required at all, if the correct information had been provided by the CPIO. The CPIO is cautioned to be careful, in future while providing information.
- 4. Shri U.C. Joshi, DR to CR is directed to provide the action taken on the said diary number and intimate the registered number, if the case has been registered to the appellant within 1 week from the date of receipt of the order.

- 5. The appeal is disposed off. IPO No.21F 074256 and No.21F 074257 for Rs.10/each are returned herewith as no fee is required to file an appeal in the Commission.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
