While taking decision of the appeal, Shri U.C. Joshi, DS & CPIO(CR) and Shri Ashok Kumar Sharma, CPIO, RTI Cell were present. The appellant in her appeal stated that the reply furnished by the CPIO(CR) on Point-1 of the RTI application is incomplete as action taken on her application sent to the Commission vide registered post No.RV605502924IN has not been intimated. Moreover, as per appellant, no information is furnished on Points 2 to 5 of the RTI application by the CPIO.

Decision with reasons:-

2. On Point-1 of the RTI application, Shri U.C. Joshi, CPIO(CR) vide letter dated 24.01.2016 has informed the appellant that her letter diarized as Dy.No.177395 dated 05.10.2016 is under scrutiny/process. In this regard, **direction is given to Shri U.C. Joshi, CPIO(CR) to intimate the present status of the above mentioned diary number to the appellant within 5 working days from the date of receipt of the order.**

3. On Points 2 to 5 of the RTI application, **direction is given to Shri Ashok Kumar Sharma, CPIO, RTI Cell to provide the information to the appellant within 5 working days from the date of receipt of the order.**

4. The appeal is disposed off accordingly.

5. In case the appellant is aggrieved by the decision, she is free to file second appeal, if she so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
