The appellant was present when Shri Krishan Avtar Talwar, DR-1, Central Registry and Shri Ashok Kumar Sharma, CPIO, RTI Cell were also present.

Brief facts of the case:-

2. During the hearing, the appellant has informed that he has not received information sought in the RTI application dated 15.12.2016 till date. In the RTI application, the appellant has sought date-wise details of the action taken on the appeals/complaints filed by him under the 25 diaries shown in the enclosure of RTI application and their registration number etc.

3. Shri Krishan Avtar Talwar, DR-1, Central Registry has requested to provide him the said list so that information can be furnished to the appellant. However, after the hearing Shri Ashok Kumar Sharma, CPIO RTI Cell has informed that the said RTI application was received in the RTI Cell on 25.01.2017 and the same was transferred to Shri Krishan Avtar Talwar on the same day vide registration No.CICOM/R/2017/00091.

Decision with reasons:-

4. Since the RTI application has already been transferred to Shri Krishan Kumar Avtar, DR-1, Central Registry, **direction is given to him to provide information to the appellant within 3 weeks from the date of receipt of the order.**


