**Brief facts of the case:-**

1. In the RTI application, the appellant has sought following information:-

1. Refer my letter dated 05.10.2016 (copy enclosed) addressed to The Hon'ble Information Commissioner (Madabhushi Sridahr). Please inform the day to day action taken/progress report from the date of its receipt till the date of reply of RTI application. Please provide copy of notings.
2. Refer your decision CIC/SA/C/2014/000185 dated 03.02.2015 (copy enclosed). Please inform the action taken against the PIOs for not providing the information in terms of para 5 of the decision. Please note that I have not been provided the information till date.
3. The names of officials who have dealt with the matter from the date of decision till the date of reply."

2. Shri Dinesh Kumar, DO to IC(SA) cum CPIO has responded as under:-

"Point no 1 & 2:- As per record your complaint filed against Registrar Cooperative Societies (GNCTD) was listed for hearing on 18.12.2014. Vide its decision dated 03.02.2015, the matter was disposed of with directions to the PIO. A communication dated 05.10.2016 (Diary no 177695) was processed and as per practice after verifying facts of receipt of reply/communication from the PIO, action for compliance of Commission's order 03.02.2015 was initiated on 25.11.2016. However, no further action could be taken in the matter thereafter as the work of hearing of appeals/complaints relating to GNCTD was reallocated to the Registry of IC(YA) vide office order dated 29.12.2016.

Accordingly on reallocation of work as stated above, the relevant file along with other records was transferred to the Registry of IC(YA) on 09.01.2017 for appropriate action. On receipt back of the RTI dated 11.01.2017 from DO & CPIO IC(YA) again in this Registry, the information available in the records is being provided after obtaining file no CIC/SA/C/2014/000185 from the registry of IC(YA) on 14.02.2017.

Point no 3:- The staff posed in the Registry of IC(SA) from time to time have dealt with this case along with other cases."

3. In the appeal, the appellant has stated that the CPIO has not provided information on any of the points, which clearly shows that no action has been taken on his non-compliance letter dated 05.10.2016 and a non-specific reply has been sent. He requested to provide him specific information on all three points of the RTI application and initiate action against officials for not ensuring the compliance of Commission's order dated 03.02.2015 and not furnishing the information. He also stated that the words IC(YA) and IC(SA) does not convey any meaning to him.

#### Decision with reasons:-

4. After going through the RTI application, reply of the CPIO and appeal, it is observed that point-wise specific information as sought in the RTI application has not been provided by the CPIO. **Since the public authority "Registrar Cooperative Societies (GNCTD)" has been reallocated to the registry of IC(YA), Shri R.P. Grover, DO to IC(YA) cum CPIO is directed to provide the point-wise specific information as sought in the RTI application to the appellant within 2 weeks from the date of receipt of the order.**

5. IC(YA) stands for Hon'ble Information Commissioner (Yashovardhan Azad) and IC(SA) stands for Hon'ble Information Commissioner (Sridhar Acharyulu).

6. The appeal is, therefore, disposed off.

7. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
