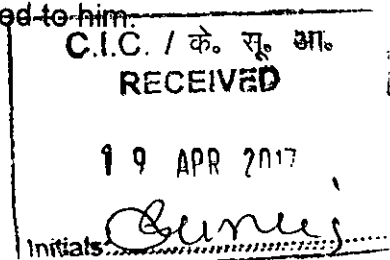

The appellant had filed a first appeal dated 22.08.2015 but it was registered as 2<sup>nd</sup> appeal and Hon'ble Information Commissioner, Shri Sudhir Bhargava has remanded the matter to the FAA for further necessary action vide Order No.CIC/SB/A/2015/000336 dated 31.03.2017.

**Brief facts of the case:-**

2. On the direction of the FAA, the appellant was contacted over his given mobile number on 17.04.2017 and 18.04.2017 by the PA to FAA. The appellant discussed the matter with the PA in detail and the appellant has intimated that since the reply of his earlier RTI application dated 09.09.2014 was received after the stipulated mandatory period of 30 days, therefore, 223 pages list of penalty for which further fee @Rs:2/- per page as demanded by the CPIO vide his letter No.3/2/2015/Admn/CIC/00122 dated 15.07.2015, may be provided free of cost u/s 7(6) of the RTI Act. He has further informed that he has not received reply of his earlier RTI application dated 09.09.2014 despite of FAA's order dated 27.01.2015. The appellant has also asked about the information sought in his RTI application dated 18.05.2015, which has been explained to him.

3. The appellant has stated over phone that the copies of penalty list may be provided to him free of cost and reply in respect to his RTI application dated 09.09.2014 may be provided to him. Besides this, the appellant has no other issues.

**Decision with reasons:-**

4. In view of the above, direction is given to Shri T.K. Mohapatra, CPIO cum DR to CR-II who is now looking after the penalty cases of the Commission to provide the list of penalty, which was running in 223 pages at the time of furnishing the information to the appellant free of cost within 3 weeks from the date of issue of this order.
