Brief facts of the case:-

In the RTI application, the appellant has sought following information in respect of case File No.CIC/B/A/2016/000268:-

- "1. This Appeal/2nd Appeal was filed in CIC in the year 2015 under Senior Citizen's Priority Category.
 - Please provide information/documentary evidence in support of confirm that this appeal was Registered and processed under Senior Citizen's Category norms established by CIC. If not treated as Appeal under Senior Citizen's by the Registrar then the reasons for not doing so should be provided.
- 2. Please check the Appeal waiting list of Shri Basant Seth, CIC and inform when and approx days/months I can expect this appeal to be listed for hearing in CIC.
- 3. Keeping in view the legal judgments holding view that delayed Rights entitlement tantamount to denial of that Right to Citizens. In essence in time delivery of Right is only Right and not otherwise. In this context please provide the list of initiative contemplated by CIC to cut short pendency of appeal/complaints.
- 2. Shri S.C. Sharma, DO to Chief IC &CPIO vide letter dated 27.03.2017 has responded that:-

"Point 1 & 2: Your appeal has been registered in the CIC vide Diary No.104289 dated 11.01.2016. It will be listed on its turn and expected to be listed within another two months."

- In case the appellant is aggrieved by the decision, he is free to file second 7. appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
