## Brief facts of the case:-

In the RTI application, the appellant has sought 3 points information in respect of Commission's Order No. File No.CIC/VS/A/2014/000958/BJ dated 29.06.2016.

- 2. Shri A.K. Talpatra, DO to IC(AB) cum CPIO vide letter dated 01.03.2017 has responded that:-
  - "(1) In compliance of the CIC order dated 29.06.2016 in case no. CIC/VS/A/2014/000958/BJ, a copy of the information furnished by the FAA vide 29.06.2016 is enclosed.
  - (2) Since the order of the CIC in this case is complied with by the respondent, there is no question to initiate any penal action u/s 20(1) of the RTI Act against the respondent."

## Decision with reasons:-

3. The appeal has been thoroughly examined and it is observed that the appellant has not mentioned anywhere as to why and on which point of the reply of the CPIO, he is aggrieved. The appellant has mentioned the case details in connection with his above mentioned 2<sup>nd</sup> appeal and requested to examine the case in deep and the necessary directions may kindly be issued as deemed fit. In this regard, it is to mention that the FAA, CIC has no jurisdiction to either comment or give his opinion on the decision of the Commission. Moreover of the commission has no jurisdiction to give any direction to the CPIO of the commission authority.



- 4. In view of the above, no intervention is required on the part of the FAA, therefore, the appeal is disposed off.
- In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
