Brief facts of the case:-

In the RTI application, the appellant has stated he had sent a non-compliance appeal dated 30.04.2014 of the Commission's Order No.CIC/RM/A/2012/001234 dated 05.03.2013, which was diarized as Diary No.132259 dated 02.05.2014 but despite of several reminders, no action has been taken to date.

2. Shri R.L. Gupta, DO to IC(MP) cum CPIO vide letter dated 22.02.2017 has responded that the case File No.CIC/DS/A/2012/001234-RM is not available in the registry and has requested I/c Record Room to make available the physical/digital records of the file so that additional information, if any, may be made available to the applicant.

Decision with reasons:-

3. While deciding the case, Shri R.L. Gupta, DO to IC(MP) has been called for who intimated that he has received the digital records of file. However, he sent an email dated 08.03.2017 to the respondent in Case No.CIC/DS/A/2012/001234-RM directing the CPIO to submit report regarding correct and complete compliance as per Commission orders to the applicant under intimation to this office urgently on the compliance to this email, Shri Sanit Debroy, JS(D&P) & CPIO, Tripura UniversectiveD

vide letter No.F.TU/RTI/02/ 20013-2014 dated 13.04.2017 addressed to Prof. Kamalakant Sharma with a copy to the DO to IC(MP) has sent the complete compliance report and provided a copy of the same as downloaded by him. The CPIO has further submitted that no information as sought in the RTI application is available in the concerned digital case file.

- 4. In view of the above submissions of the CPIO, it is observed that factual information about the case File No.CIC/DS/A/2012/001234-RM has been furnished by the CPIO, therefore, no intervention is required on the part of the FAA.
- However, a copy of email dated 08:03:2017 of the DO to IC(MP) and letter dated 13:04:2017 of Shri Sanit Debroy, JS (D&P) & CPIO as provided by the CPIO are enclosed herewith.
