This first appeal has been marked to some other section inadvertently and received in the office of the FAA on 13.04.2017.

2. The appellant has requested for hearing through video conferencing. But since the VC system is out of order, the appellant has been informed over his given mobile number on 19.04.2017 about it and sought his willingness either present his case through audio-conferencing or appear personally or through an authorized representative but he insisted for VC. On 20.04.2017 evening, the appellant was again contacted but he did not attend the call. Since the appeal is lying pending from 03.01.2017 in the Commission, which is to be disposed off in time bound manner as per RTI Act and no further response received from the appellant, the appeal is being decided on the basis of available material on record.

Brief facts of the case

- 3. In the RTI application, the appellant has sought copy of document received, with notings and further proceedings in respect of 09 Diary Numbers of 2016.
- 4. CPIO, RTI Cell has transferred the RTI application to all concerned CPIOs in the Commission for providing information. All concerned CPIOs have furnished the information available with them about their concerned diary numbers except DR in Central Registry who has not furnished any information on Points 1 & 2 of the RTI application.



On perusal of the RTI application and reply of the CPIOs, it is observed that Shiri V.K. Sharma, DO to IC(SB) on Points 7 & 9 has not provided the copy of

documents, notesheet and further proceedings, if any as sought by the appellant in the RTI application. Direction is accordingly given to Shri V.K. Sharma, DO to IC(SB) cum CPIO to provide information, if available, to the appellant within 2 weeks from the date of receipt of the order.

- On Points 5 & 6 of the RTI application, Shri V.K. Sharma, DO to IC(SB) has responded in his reply that "Diary Nos. 153150 and 153151 both dated 11.07.2016 have not been received in this registry". On perusal of the dak status of these two numbers, it is found that the these are marked to Nodal CPIO. In this regard, direction is given to Shri Ashok Kumar Sharma, CPIO, RTI Cell to provide information to the appellant within 1 week from the date of receipt of the order.
- On Points 1 & 2 of the RTI application, no information has been provided by 7. the CR Section, direction is accordingly given to Shri Krishan Avtar Talwar, DR & CPIO to CR-1 to provide the present status of two Diary No.108928 dt. 27.01.2016 and Diary No.132777 dt. 05.05.2016 as sought in the above points to the appellant within 2 weeks from the date of receipt of the order.
- Information provided by CPIO on other points is factual and appropriate, 8. therefore, no intervention is required on the part of the FAA.
- Further on perusal of the appeal, it is observed that the appellant has raised 9. several issues and suggestions regarding functioning of RTI Cell, Registries and FAA of the Commission. In this regard, the appellant is advised to send these issues/suggestions separately to the Commission because it is not in purview of FAA.
- The appeal is, therefore, disposed off. 10.
- In case the appellant is aggrieved by the decision, he is free to file second 11. appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
