Brief fact of the case:-

In the RTI application, the appellant has sought following information:-

- "1. Please provide information containing list of the number of complaints and second appeals pending with Hon'ble Central Information Commission, filed by the complainants and appellants against the 'Delhi International Airport Ltd', 'DIAL'.*
- 2. Further, to Question No (1) provide information, since from which each date, complaints and appeals are pending.*
- 3. Further, to Question No (1) and (2), provide names of the complainants and appellants, whom filed the petitions.*

2. In response to above, Shri R.L. Gupta, DO to IC(MP) vide letter that 28.02.2017 has intimated that no file relating to DIAL is available and requested Shri K.A. Talwar, DR to CR-1 to supply information, if available in the CR Section/any full bench reference is pending. Shri Talwar vide letter dated 06.03.2017 that requisite information would only be available with the registry under whose jurisdiction Ministry of Civil Aviation, as a public authority falls i.e. with Shri R.L. Gupta, DO to IC(MP) and he also forwarded a reply dated 28.02.2017 of the Registrar, CIC to the appellant.

Decision with reasons:-

3. From the perusal of the RTI application, reply of the CPIO(s) and appeal, it is observed that information as sought by the appellant has not been furnished to him.

The matter was lingering between DR cum CPIO to CR-1 and DO to IC(MP) cum CPIO, which should have been avoided.


4. It is also observed that the holder of the information, in this particular case is JS(MR) section, direction is accordingly given to Shri Jeewan Chandra, Consultant/CPIO(MR) to provide suitable information to the appellant by taking the assistance of JS(MR) within 3 weeks from the date of receipt of the order.

5. As regards reply received after 30 days, it is to mention that the CPIO has furnished the information on 06.04.2017 i.e. before the completion of 30 days. However, the CPIO is advised to take note of it and furnish information in response to any RTI application well in time, in future.

6. The appeal is, therefore, disposed off.


