Brief facts of the case:-

3. In the appeal, the appellant has mentioned that information provided by the Dak Section is not complete as per the RTI application.


Decision with reasons:-

On perusal of the reply of CPIO, Dak Section, it is observed that she has also endorsed a copy of the reply dated 28.03.2017 to all concerned to whom the above mentioned diary numbers were sent. **Direction in this regard is given to Shri Ashok Kumar Sharma, CPIO, RTI Cell to seek information under Section 5(4) of the RTI Act as sought on Para I to VII of the RTI application from the concerned CPIOs/Deemed CPIOs and provide a consolidated information to the appellant within 3 weeks from the date of receipt of the order.**

5. The appeal is, therefore, disposed off.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
