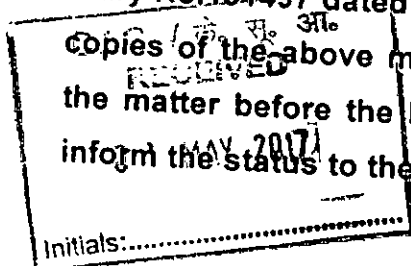
**Brief facts of the case:-**

In the RTI application, the appellant has sought 7 points information in respect of her complaint dated 05.02.2015 and its reminder dated 09.12.2016 in connection with case File No. CIC/AD/A/2013/001891-SA, CIC/DS/A/2013/001127-SA, CIC/DS/A/2013/001128-SA and CIC/DS/A/2013/001132-SA.

2. Shri Dinesh Kumar, DO & CPIO to IC(SA) vide letter dated 28.02.2017 has informed the appellant that above mentioned case files heard by the Commission on 28.04.2014, decided on 30.04.2014 have been transferred to the record room of CIC for scanning and retention. He further stated in the reply that since the work of GNCTD has been re-allocated to the registry of IC(YA), therefore, the communication dated 09.12.2016, diarized as Diary No.191497 dated 16.12.2016 has been sent to the registry of IC(YA) along with the reply.

**Decision with reasons:-**

3. On perusal of the RTI application, reply of the CPIO and request made in the appeal, direction is given to Shri R.P. Grover, DO & CPIO to IC(YA) to whom the Diary No.191497 dated 16.12.2016 has been sent to obtain physical or scanned copies of the above mentioned 4 case files from I/c Record Room and place the matter before the Hon'ble Information Commissioner for his perusal and inform the status to the appellant accordingly.
