Brief facts of the case:-

In the RTI application, the appellant has sought following information:-

- "1. Information if our letter NO.J5/626/2016-17 dtd:15-11-2016 was read by CIC or IC in Central Information Commission.
- If filed, it was filed at whose instruction?
- 3. If destroyed, it was destroyed at whose instruction.
- If no action taken it is at whose instruction."
- 2. Shri K.L. Das, CPIO & DO to IC(BJ) vide letter dated 11.04.2017 has responded that:-
 - ".. Point No.1 There is nothing on record to say whether it was read by CIC/IC or not.

Point Nos 2&4 No such information is available on record.

Point No.3 It has not been destroyed."

3. Aggrieved with the response of the CPIO, the appellant has filed this first appeal. On the grounds of the appeal, the appellant has stated that there must be set instructions for disposal of dak received. CPIO's reply is not digestible that nobody has seen and put any remark. The letter is lying as it is in the section. This shows there is no system followed in CIC for disposal. This cannot be and therefore I may be provided with the required information as per my RTI application.
