Brief facts of the case:-

In the RTI application, the appellant has sought action taken by the Secretary, CIC on the email dated 07.03.2017 of the appellant forwarded by Shri Madan Mohan Maurya, Under Secretary to Govt. of India, DoPT vide his letter dated 16.03.2017 to the Secretary, CIC.

- 2. Shri Ashok Kumar Sharma, CPIO, RTI Cell has sought assistance under section 5(4) from the PA to Secretary, CIC who intimated that the above said letter of the DoPT was forwarded to JS(Admn) for taking action vide Diary No 1029 dated 17.03.2017. CPIO, RTI Cell has further sought assistance from JS(Admin) who intimated that a complaint of Mr. Kamal Bhasin has been received and is under consideration/examination.
- 3. Aggrieved with the response of the CPIO, RTI Cell, the appellant has filed this appeal.

Decision with reasons:-

4. On perusal of the RTI application, reply of the CPIO and appeal, it is observed that reply furnished by the CPIO is appropriate. However, direction is given to Shri Ashok Kumar Sharma, CPIO, RTI Cell to seek latest status of the above mentioned complaint from JS(Admn) within 2 weeks from the date of receipt of the order and inform the appellant accordingly.
