**Decision with reasons:-**

3. During the hearing, the appellant has stated that he is perplexed with the reply of the CPIO as the content of the reply does not give any meaning in reference to information sought.

4. Shri Kishore Kumar Pukhral, CPIO(Legal Cell) has informed that information sought in the RTI application is not available in the file and factual position was informed to the appellant.


