**Brief facts of the case:-**

3. In the appeal, the appellant has stated that the reply of the CPIO is misleading and irrelevant in context of his query. The CPIO has provided Bank's letter dated 13.02.2017 without its enclosures and requested to provide certified photocopy of enclosures of the bank's letter dated 13.02.2017.


