2. In the RTI application, the appellant has sought action taken report on her complaint dated 12.11.2016.

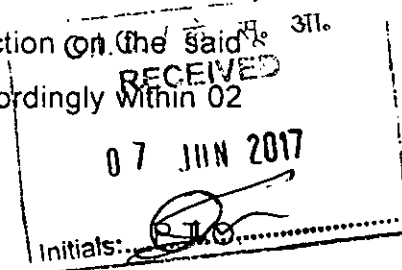
3. Shri R.P. Grover, CPIO & DO to IC(YA) vide letter dated 15.05.2017 has responded that:-

Decision with reasons:-


4. In the appeal, the appellant has alleged that reply of the PIO is not correct and misleading that the complaint is not found in the file. She has enclosed a copy of the complaint dated 12.11.2016 and requested to direct PIO to give her correct reply. A copy of the complaint as provided by the appellant is enclosed herewith with the direction to Shri R.P. Grover, CPIO & DO to IC(YA) to take action on the said complaint, if any required to be taken and inform the appellant accordingly within 02 weeks from the date of receipt of the order.
