Brief facts of the case:-

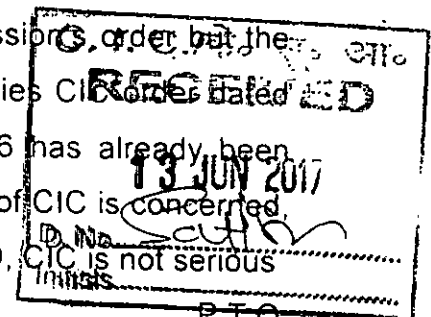
In the RTI application, the appellant has sought 5 points information in respect of case file No.CIC/SA/A/2016/000848.

2. Shri R.L. Gupta, CPIO & DO to IC(MP) vide letter dated 17.04.2017 has responded that:-

".....records of file CIC/SA/A/2016/000848 has been received from DR(IC-SA) today i.e. 05.04.2017 and it has been perused carefully. The information as asked for by the applicant in his RTI application dated 29.03.2017 is not available on the records of the file. The said appeal of the applicant has been closed vide order dated 22.06.2017 by the Hon'ble Information Commissioner and the CPIO has forwarded a communication dated 10.08.2016 in compliance of the Commission order to this Commission as well as to the applicant.

However it is for the information of the applicant that there is no provision, under the RTI Act 2005 and the Rules made there under, for review of decision in an appeal/complaint....."

3. In the appeal, the appellant has stated that CPIO has forwarded a communication dated 10.08.2016 in compliance of the Commission's order but the letter dated 10.08.2016 neither responds his queries nor complies with the Commission's order dated 22.06.2016. In this regard a complaint letter dated 21.07.2016 has already been submitted in the CIC. So far as the matter of review of decision of CIC is concerned, RTI application is not concerned with it. He also stated that CPIO, CIC is not serious



towards his RTI application, which can be seen by the statement of the CPIO that the said appeal of the applicant has been closed vide order dated 22.06.2017, which is still far away of about one month. Hence, he has requested to take stern action against CPIO, CIC for delaying information.

Decision with reasons:-

4. In this regard, Shri R.L. Gupta, CPIO & DO to IC(MP) was called for along with the concerned case file. Shri Gupta with regard to the wrong date of the order has intimated that this was a typographical error. He further informed that a letter No.JNU/RTI/CPIO/5096/2015/456 dated 08.05.2017 has been received on 24.05.2017 from Dr. Abha Yadav, DR(Legal) & CPIO, JNU. This letter is addressed to the appellant with a copy to him vide which respondent CPIO has offered inspection of records to the appellant on any working day. The respondent CPIO has also stated that no more information in this respect is held/available in the office of CPIO. Hence, the appellant should inspect the records, if he needs more information on his RTI application. Shri Gupta has stated that no more information is available with the registry of IC(MP) and as per above said letter the order of the Commission has been complied with by the respondent, which might have also been received by the appellant.

5. In view of the above, it is observed that the CPIO has furnished factual information to the appellant, therefore, no further direction can be given to the CPIO. However, a copy of the letter dated 08.05.2017 of the respondent CPIO as provided by the CPIO, CIC is enclosed.

6. The appeal is, therefore, disposed off.

7. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
