**Brief facts of the case:-**

In the RTI application, the appellant has sought list of the employees, name and designation to whom the advisory memo was issued as intimated by the DR/CPIO vide his letter No.CIC/CPIO/CR/2014/0057 dated 01.04.2014.

2. Shri Krishan Avtar Talwar, CPIO & DS to CR-1 vide letter dated 18.05.2017 has responded that:-

*"Perusal of case file no. CIC/CPIO/CR/2014/0057 reveals that there is no such written note issues/available. It seems that perhaps Shri K.L. Das, Deputy Registrar & CPIO in his reply dated 01.04.2014 was referring to verbal directions/instructions issued to the officials working in the Registry."*

3. In the appeal, the appellant has stated that CPIO has not provided requisite information as per his RTI application dated 21.04.2017 and requested to provide the same.

**Decision with reasons:-**

4. Shri Krishan Avtar Talwar, CPIO was called for along with the concerned case file and on perusal of the file, it is observed that no advisory memo is available on record. Therefore, the CPIO has given factual information on the basis of record available with him.


