Brief facts of the case:-

The appellant has filed two first appeals dated 03.06.2017 in response to his RTI application dated 26.04.2017. One appeal is filed against the response of CPIO Dak Section dated 04.05.2017. In this appeal, the appellant has mentioned that the CPIO, Dak Section has provided incomplete information on Point-(i) of the RTI application as the CPIO has only informed the diary number of the review application dated 09.01.2017 of the appellant and not informed the date of receipt of the review application in the Commission as sought in the RTI application.

2. The second first appeal is filed against the reply of Shri R.L. Gupta, CPIO cum DO to IC(MP) who has informed the appellant that review application dated 09.01.2017 is not available in the concerned case files and requested CPIO, Dak Section and DR to IC(SB) to forward the review application to his registry for further necessary action. In the appeal, the appellant has stated that the CPIO has informed the above said status vide letter dated 05.05.2017 but even after one month, CPIO has not furnished the information.

Decision with reasons:-

3. On Point – (i) of the RTI application, CPIO, Daks Section has provided dak entry details of the diary number 102244. As per entry details, review application dated 09.01.2014 was received in the Commission on 12.01.2017. A copy of entry dak details is enclosed.



4. On Points (ii) to (v) of the RTI application, Shri R.L.
