## Brief facts of the case:-

In the RTI application, the appellant has sought following information in respect of his complaint dated 30.01.2017 regarding non-compliance of CIC order No.CIC/LS/A/2013/000989 dated 01.07.2013:-

- "1. Date of receipt of above said complaint by CIC
- 2. Copy of Noting of competent authorities
- 3. Copy of orders/instructions if any issued by competent authorities in above said complaint.
- 4. Present status of above said complaint"
- 2. Shri Krishan Avtar Talwar, DR to CR-1 & CPIO vide letter dated 29.05.2017 has informed that the letter dated 30.01.2017 diarized as diary no.107412 and registered vide case No.CIC/OFBKO/C/2017/107412. He further gave the contact number of Shri S.S. Rohilla, CPIO & DO to IC(SB) who is dealing with the said case, for further information, if any.
- 3. In the appeal, the appellant has stated that he has no objection on the reply given on point-1 of the RTI application. On points 2 to 4, no information has been provided and requested to provide information free of cost.

## Decision with reasons:-

4. On perusal of the RTI application, reply of the CPIO and appeal, it is observed that information on points 2 to 4 has not been provided to the appellant. Since the case file No. CIC/OFBKO/C/2017/107412 is concerned with the registry of IC(SB), as informed by DR to CR-1, direction is accordingly given to Shri S.S. Rohillaro STIO & DO to IC(SB) to provide information on points 2 to 4 of the RTIED application to the appellant within 1 week from the date of receipt of the order.
