Brief facts of the case:-

- 2. Copy of Noting of competent authorities
- 3. Copy of orders/instructions if any issued by competent authorities in above said complaint.
- Present status of above said complaint"
- 2. Mrs. Pushpa Janardhanan, CPIO, Dak Section vide letter dated 01.06.2017 has responded that "As per computerized Dak Management System your letter dated 30.01.2017 has been diarized vide Diary No.107127 and forwarded to the Registry of DO to IC(DP)."
- 3. In the appeal, the appellant has stated that he has no objection on the reply given on point-1 of the RTI application. On points 2 to 4, no information has been provided and requested to provide information free of cost.

Decision with reasons:-

4. On perusal of the reply furnished by the CPIO, Dak Section, it is observed that information furnished by her is appropriate as being CPIO of Dak Section, she has information only about diarisation of dak and to whom it is sent. Further, it is also observed that CPIO, Dak Section has endorsed a copy of her reply dated 01.06.2017 to the DO to IC(DP) with the request to reply directly to the applicant. Direction is accordingly given to Shri H.P. Sen, CPIO & DO to IC(DP) to provide information on points 2 to 4 of the RTI application to the appellant within 1 week from the date of receipt of the order.
