Brief facts of the case:-

In the RTI application, the appellant has sought status of his case File No.CIC/SA/A/2014/001668. The appellant was contacted over his given mobile number who informed that the ibid case was last heard by Prof. M. Sridhar Acharyulu, Information Commissioner on 28.10.2016 who issued show cause notice for penalty to four PIOs of Registrar Cooperative Societies and also directed the respondent officer to take last chance for submitting their explanation, within 21 days from the date of receipt of this order.

2. As per RTI application, Shri R.P. Grover, CPIO & DO to IC(YA) has informed over phone to the appellant that the case file is not traceable.

On perusal of the appeal, it is observed that the appellant has enclosed a copy of the reply dated 19.04.2017 of Shri Dinesh Kumar, CPIO & DO to IC(SA) who intimated status of the case File No.CIC/SA/A/2014/001668 and also sent the said case file to DO to IC(YA) since the public authorities under GNCTD was reallocated to the registry of IC(YA). 
