**Brief facts of the case:-**

In the RTI application, the appellant has sought all the documents related to case File No.CIC/LS/C/2012/000427/SD.

2. Shri S.S. Rohilla, CPIO & DO to IC(SB) vide letter No.CICOM/R/2017/00552/SB dated 26.05.2017 has responded that:


