**Brief facts of the case:-**

In the RTI application, the appellant has sought following information:-

- "1) Whether Hon'ble Commission has received 2 Demand Drafts each of Rs.2500/- deducted from the Pension paid on 31.05.2017 to Shri Biren Kumar Patnaik, Retired CPIO and Shri Amulya Swain, Retired Chief Manager, DIR – **both of United Bank of India** in terms of Order dated 11.04.2017 passed by Hon'ble IC, Shri Sharat Sabharwal on File No.CIC/SH/A/2015/001176 on my Complaint u/s 18 r/w s.20."
- 2) If answer to query no.1 is no, has the Commission received any Stay Order on the implementation of above Order of Hon'ble IC from any Competent Court?
- 3) Kindly provide me the number of Complaints pending for Non-compliance of Orders of Shri Sharat Sabharwal, Hon'ble IC and different dates of such Orders which are not complied."

2. In the appeal, the appellant has stated that he sought information on 3 points. First is replied, second is transferred and third is ignored, i.e. neither replied nor denied or transferred. He has requested to provide correct, complete and relevant information on third query.

**Decision with reasons:-**

3. On perusal of the case file, it is observed that information on Points 2 & 3 has also been provided by CPIO (Legal Cell) vide letter dated 21.06.2017 and Shri Vijay Bhalla, CPIO & DO to IC(SH) vide letter dated 15.06.2017 respectively. **A copy of both the letters is enclosed.**
