**Brief facts of the case:-**

In the RTI application, the appellant has sought soft copy/CD of the video conference held on 22.05.2017 in case No.CIC/EPFOG/A/2017/116215, which was attended by appellant on behalf of the client E.S.I. Corporation, Regional Office, Kolkata.

2. Shri Dinesh Kumar, CPIO & DO to IC(SA) vide letter dated 02.06.2017 has informed that "recordings of the Video Conferencing held in the Commission during hearing of Appeals/Complaints are **not** being made".

3. In the appeal, the appellant has stated that it is quite surprising that the ground stated in the letter/reply dated 02.06.2017 is not at all a satisfactory one and he failed to understand as to how a video conference was made without recording as it is alleged in the said reply. Therefore, appellant requested to make necessary measure for supply of soft copy of the video recording at the earliest.


**Decision with reasons:-**

4. On perusal of the RTI application, reply of the CPIO and appeal, it is observed that the CPIO has rightly replied that the Commission does not maintain any recording of Video/Audio hearing, hence no intervention is required.

5. The appeal is, therefore, disposed off.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
