## Brief facts of the case:-

In the RTI application, the appellant has mentioned the 3 points background of the information to be sought, which is related to File No.CIC/BS/A/2016/000742 and sought the following information:-

"As, in the normal course, there is good amount of/substantial time lag/wait for the complaint/appellate cases to come up for hearing, it is requested to provide me the information on the methodology/procedure to be used for listing of this matter on urgent/immediate/priority basis as the issue involves not only non compliance of CIC orders but also non payment of my PF/NSSF dues of Tanzania by Reliance Industries."

2. Shri Dinesh Kumar, CPIO cum DO to IC(SA) vide letter dated 21.06.2017 informed the appellant that:-

"Your second appeal no.CIC/BS/A/2016/000742 was heard by the Commission on 14.03.2017 and by disposing of the same the Commission in its decision dated 14.03.2017 directed the respondent authority, EPFO, RO, Mumbai-1 to provide information about action taken against RIL for non-payment of his PF dues and to inform him by when his PF dues would be paid to him, within 21 days from the date of receipt of this order. A copy of the decision of the Commission was sent to the respondent. Your communications dated 08.05.2017 (Diary No.130444 & 130445 dated 08.05.2017 regarding Non-Compliance of the Commission decision have been received in this registry on 19.05.2017 from CR-II Section.

As per records no information has been received from the respondent and vide letter dated 08.06.2017 (copy endorsed to you) the position has been ascertained from him."

## Decision with reasons:-

On perusal of the RTI application, reply of the CPIO and appeal it is observed that the CPIO has not provided actual information sought by the appellant. The appellant sought the procedure/methodology to be used for listing of non compliance matter on urgent/immediate/priority basis. In this regard, appellant may go through the FAQs link in CIC's website <a href="http://cic.gov.in/faq#n3394">http://cic.gov.in/faq#n3394</a> which states that:-

"Receipt of second appeals/complaints is a continuous process and they are disposed of as expeditiously as possible. The complaint/appeal is taken up as per its turn. A priority hearing is accorded in a particular case or class of cases as per orders of the Chief IC/IC concerned......"

The same procedure is also being followed on the non-compliance cases.

- 4. The appeal is, therefore, disposed off.
- 5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
