Brief facts of the case:-

In the RTI application, the appellant has sought copy of the confidential letter in connection with case File No.CIC/LS/A/2013/001563/SD.

2. Shri H.P. Sen, DO to IC(DP) & CPIO vide letter dated 07.07.2017 has stated that:-

"This has reference to your RTI application dt.30.03.2017 received vide CIC Regn No.CICOM/R/2017/00820 dated 05.07.2017. It may be mentioned that the confidential letter sent to DG DE by the Directorate of Defence Estates, Central Command, Lucknow Cantt. is not available in the file. The CIC is, therefore, unable to arrange the said communication for you."

3. In the appeal, the appellant has stated that CPIO should transfer the RTI application to the CPIO, Dt.DE Lucknow in terms of sec.6(3)(i) of RTI Act and thereafter, in terms of sec.7(i) of RTI Act, the CPIO, Dte. DE Lucknow has to furnish the copy of the confidential letter sent to DGDE, since it is not exempted under provisions of sec. 8(a) of the RTI Act. She requested that the CPIO may be directed to proceed according to the provisions of RTI Act as mentioned above.




Decision with reasons:-

4. On perusal of the RTI application, reply of the CPIO and appeal, it is observed that factual information has been furnished by the CPIO, therefore, no intervention is required on the part of the FAA.

5. The appeal is disposed off.


