Brief facts of the case:-

In the RTI application, the appellant has requested to send him the reply of his appeal dated 01.03.2017 sent to the Commission.

2. Shri Krishan Avtar Talwar, DR to CR-1 cum CPIO vide letter dated 30.06.2017 provided following information to the appellant:-

"You have not asked any specific information. However it is stated that appeal dated 01.03.2017 has already been registered vide No.CIC/LICOI/A/2017/115267 and would be listed for hearing by the respective registry in due course of time"

3. In the appeal, appellant has requested to decide the appeal at the earliest so that he may get the benefit of the policy purchased from LIC, Mandi Branch, HP.

Decision with reasons:-

4. On perusal of the RTI application, reply of the CPIO and request made in the appeal, it is observed that the appellant is not aggrieved with the response of the CPIO. He only prayed in the appeal to give direction to the CPIO to decide his appeal at the earliest. In this regard, it is to mention that cases are decided on first cum first serve basis in the Commission. The above mentioned case shall also be decided on its own turn. The Commission has made provision for priority hearing for senior citizen (aged 65 year and above) only. If the appellant falls under this category, he may send a request along with proof of age w.r.t. his above registered appeal.

5. The appeal is disposed off.
