Brief facts of the case:-

In the RTI application, the appellant enclosed copy of his 2nd appeal dated 05.07.2014 and special leave petition dated 01.10.2014 and sought following information:-

1. My Second appeal, as mentioned at serial 2 above, also copy attached has been pending before the Hon'ble CIC for the last 3 years. Kindly inform when the same is likely to come up for hearing. Sir, I am an old man of 80 years age, suffering from several ailments.
2. Inform status of my two 2nd appeals dt. 29.5.11 and one dt. 5.11.13.
3. Action taken on my "Urgent Application" addressed to the Registrar, CIC, Club Building (near P.O), Old JNU Campus, N.D-67 attached with my 1st appeal dt. 05.07.14.
4. Kindly inform status of my special leave petition as mentioned at serial 3 above. When and on what date the same is likely to come up for hearing. A period of about 2 ½ years has already passed and my petition contains something very important.
5. Any other relevant very important.

2. Mrs. Pushpa Janardhanan, CPIO, Dak Section vide letter dated 04.07.2017 provided following information to the appellant:-

"Point 1 & 3: Our Computerised Dak Management System does not reflect the receipt of your letter dated 05.07.2014.

Point 2: As per our computerized Dak Management your letter diarized vide Diary Number 173641 dated 09.10.2014 has been sent to registry of DO to IC(SA).

Point 4: As per our computerized Dak Management System your letter diarized vide Diary Number 173641 dated 09.10.2014 has been sent to registry of DO to IC(SA).

Decision with reasons:-

3. On Points 1 & 3 of the RTI application, the appellant has stated that information provided on these two points is not correct as he sent his 2nd appeal through Trackon Courier Post No.402709588 on 7th July 2014 duly addressed to the Hon'ble Central Information Commission, Club Building (Near Post Office), Old JNU Campus, N.D.-67, which must have been delivered there on 8/7/14 or 9/7/14. Moreover, he also sent a copy of the said 2nd appeal (11 pages) along with the RTI application and requested to consider the same. **A copy of the same along with its enclosures as enclosed in the RTI application is forwarded to Shri Krishan Avtar Talwar, DR to CR-1 with the direction to register it as per the provisions under the Act and inform the appellant accordingly within 3 weeks from the date of receipt of the order.**

4. On Point-2 of the RTI application, appellant has stated that status of his 2nd appeal dated 29.08.2011 has been concealed. The decision enclosed by CPIO, Dak Section is of his 2nd appeal dt. 08.11.2013, which is already with him. The 2nd appeal dated 29.08.2011 was sent through Ocean Express Courier No.25267124 dt. 30.08.2011 on the address, Club Building (near P.O), Old JNU Campus, N.D.-67, which must have been delivered on 31.08.2011 or 01.09.2011. The CPIO has failed to reply on this point. **Direction in this regard is given to Mrs. Pushpa Janardhanan, CPIO (Dak Section) to intimate status of the 2nd appeal dated 29.08.2011 to the appellant within 3 weeks from the date of receipt of the order.**

5. On Point-4 of the RTI application, appellant has stated that the information provided by CPIO, Dak Section is incomplete and evasive. It is not clear as to whether the letter concerned has been sent to registry now after the receipt of RTI application or it had been sent when the same was received in the Commission three years back. He wanted information on the present status of his Special Leave Petition which has not been provided. The matter was enquired with the CPIO, Dak Section who informed that status of Diary No.173641 dated 09.10.2014 was checked from the computerised dak management system, therefore, the said diary number was sent to the registry of IC(SA) on receipt and diarisation. **As regards status of the same, direction is given to Shri Dinesh Kumar, DO to IC(SA) cum CPIO to provide present status to the appellant within 2 weeks from the date of receipt of the order.**

6. The appeal is disposed off.

7. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
