Brief facts of the case:-

In the RTI application, the appellant has sought 03 points information in respect of his 2nd appeals diarized in the Commission vide No.103058 dated 16.01.2017, 108309 dated 08.02.2017 and 113474 dated 28.02.2017.

2. Shri Krishan Avtar Talwar, DR to CR-1 cum CPIO vide letter dated 04.08.2017 informed the appellant that said diary numbers are already registered vide File No.CIC/CICOM/A/2017/103058, CIC/CICOM/A/2017/108309 and CIC/CICOM/A/2017/113474 respectively and for responding to other issues, he forwarded the RTI application to Shri S.S. Rohilla, CPIO & DO to IC(SB).

3. In the appeal, appellant has stated that CPIO has not furnished complete information as sought in the RTI application and requested to provide rest of the information on Points 'B' and 'C' of his RTI application.

Decision with reasons:-

4. On points 'B' and 'C' of the RTI application, appellant has sought following information:-

"B. Please provide latest status of my above referred II appeals.

C. Please provide the approximate time by when my II appeals are to be registered, if not yet registered please."

5. On point 'B', the matter was enquired from Shri S.S. Rohilla, CPIO & DO to IC(SB) who informed that information has already been furnished to the appellant vide his letter dated 11.08.2017. **A copy of the same as provided by the CPIO is enclosed.**

6. As regards Point 'C', all the three diary numbers have been registered, which has already been informed by Shri Krishan Avtar Talwar, CPIO cum DR to CR-I.
