Appellant was present. Shri Jeewan Chandra, CPIO(MR) and Shri Ashok Kumar Sharma, CPIO, RTI Cell were also present.

**Brief facts of the case:-**

In the RTI application, appellant has sought 16 points information in respect of case file No.CIC/RM/A/2012/001234.

2. Shri Jeewan Chandra, CPIO(MR) has provided point-wise information to the appellant vide letter dated 14.08.2017.

**Decision with reasons:-**

3. During the hearing, appellant has submitted that the digitalized case file No.CIC/RM/A/2012/001234 has been received in his email as sent by the CPIO. On perusal of the digitalized case file, it is found that only 4 pages are there. In this case, Commission had issued show cause notice to the respondent, which is not found in the said digitalized case file. The reply of that show cause notice is also not found in that digitalized case file. So the digitalized case file is incomplete. Recently, he has received a hearing notice on the non-compliance/complaint filed by him in connection with the above mentioned order of the Commission in which case file number has been changed. Initially the case file number was CIC/RM/A/2012/001234 now this case file number is given separate number i.e.

P.T.O.

CIC/RM/C/2013/000167, hearing of which scheduled on 14.09.2017 at 1100 hrs before the Hon'ble Information Commissioner, Ms Manjula Prasher. This may create doubts as complete documents of the original case file may not be placed before the Commission in the case file given separate number.

4. Shri R.L. Gupta, DO to IC(MP) cum CPIO was also called during the hearing and enquired the matter regarding incomplete digital file as mentioned by the appellant.

5. In view of the above, it is observed that the appellant is not aggrieved with the information provided by the CPIO(MR). But he is aggrieved because complete documents of his case are not incorporated with the case file scheduled to be heard on 14.09.2017. Direction is accordingly given to Shri R.L. Gupta, DO to IC(MP) cum CPIO to:-

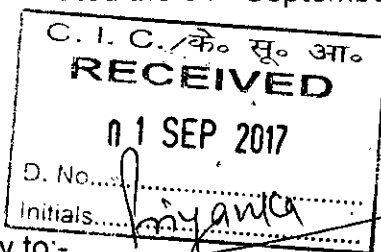
(a) get all the link papers of the case file scanned and uploaded in the relevant case file before the scheduled hearing. The appellant may be informed accordingly.

(b) As regards change of file number of same case, as pointed out by the appellant may be looked into in consultation with JS(MR), if required and take action as deemed fit.

6. The appeal is, therefore, disposed off.

7. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
