Brief facts of the case:-

In the RTI application, appellant has sought 6 points information in respect of Commission's decision dated 27.04.2017 in case File No.CIC/SH/A/2016/00450, 001095, 001150.

- 2. Shri Vijay Bhalla, DO to IC(SH) cum CPIO vide letter dated 18.07.2017 has provided information on Points 1 to 3 of the RTI application and Points 4 to 6 forwarded to SO(Legal) who further forwarded the same to CPIO(Admn). CPIO(Admn) vide letter dated 14.08.2017 has provided information on Points 4 to 6 that "There is no Citizen Charter in the Central Information Commission".
- 3. In the appeal, appellant has stated that:-

"I have sought for information with regard to action taken in respect of CIC order dated 27.04.2017 vide my RTI application dated 10.07.2017. But, none of the CPIO has provided the correct information till date. Though the Commission has directed the KARNATAK VIKAS GRAMIN BANK to provide the information within 30 days, the bank did not provide the information till date. The CIC is required to ensure the compilation of its order. Hence, I am filing this appeal for directing the poncerned CPIO to provide correct and complete information in this regard.

Decision with reasons:-

- 4. As far as information sought in the RTI application is concerned, it is observed that point-wise factual information has been provided by CPIOs. As per appeal, the appellant is aggrieved with the non-compliance of the order of the Commission. In this regard, it is to be mentioned that if the orders of the Commission is not complied with by the respondent public authority, appellant may file non-compliance of the orders in the Commission against the public authority as per instructions given in the order dated 29th November, 2016 (**copy enclosed**). The appellant may also file online non-compliance case for which he may visit CIC's website link http://dsscic.nic.in/cicapp/online-link-paper-compliance/add.
- 5. The appeal is disposed off.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
