Brief facts of the case:-

In the RTI application, appellant has sought following information:-

"Kindly arrange to supply me following documents/CD i.e. recorded evidence of Representative of PIO in my case Diary No.104882/2017 hearing held on 19.01.2017 at 03.00 PM & 03.10 PM, the details of requirement is as under.

- 1) The copy of order passed by the commission in my both appeal cases dated 07.01.2015 and 27.01.2015 reference in the Diary No.104882/2017 hearing held on 19.01.2017 at 03.00 PM & 03.10 PM.
- 2) The copy of proceedings of hearing held in the above cases on 19.01.2017.
- Shri S.L. Khot, APO/Central Railway Solapur attended as Representative of PIO. I require his recorded evidence by way of video conferencing in the above case hearing held on 19.01.2017 at 03.00 PM onwards in a form of CD."
- 2. Shri Krishan Avtar Talwar, CPIO, CR-1 vide letter dated 08.08.2017 has informed the appellant that diary No.104882 dated 24.01.2017 reflects that it was returned vide Defect Memo (now known as Facilitation Memo) dated 22.02.2017 and as per practice, all documents are returned back to the applicant while sending him DM/FM, so as to facilitate him to resubmit his case/petition again after removal of deficiencies pointed out therein. As such in the absence of relevant documents it is not possible to ascertain the case on which hearing held on 19.01.2017 at 03.00 PM & 03.10 PM and deliberate or provide any information on the issues raised by you in the RTI application.
