**Brief facts of the case:-**

In the RTI application, the appellant has sought following information:-

“1. The nature of action taken on my letter/E mail cited regarding the introduction in syllabus of Schools/Colleges about Right to information Act 2005 and Consumer Protection Act 1986.

2. The Public Authorities were attended RTI Act Training Class and if so inform the date and place of training attended.

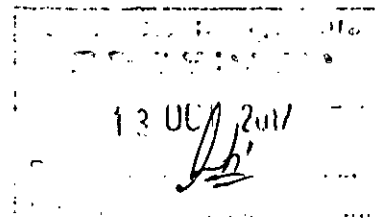
3. The name and qualification of the Central Public Information Officer/Asstl Central Public Information Officer and First Appellate Authority under RTI Act 2015.

4. The date of receipt of RTI Act applications/Date of reply sent/date of disposal if any during the period from January 2017 to August 2018.....”

Earlier the appellant has sent first appeal through email dated 23.09.2017 on which he has been advised to file first appeal through proper mode i.e. either online through RTI portal or by post. Since the appeal is received in physical form, it has been registered accordingly.

2. In the appeal, the appellant has stated that CPIO has informed that the letter dated 05.07.2017 has been forwarded to JS(Admin) but the CPIO has not given any reference number and date in which said application has been sent. This information is enough for query No.1 of the RTI application and requested to instruct the CPIO for providing information on remaining 4 queries of the RTI application.

3. On perusal of the case file of RTI Cell, it is observed that Shri Ashok Kumar Sharma, CPIO, RTI Cell vide letter No.CICOM/R/2017/01118 dated 05.10.2017 forwarded the response dated 04.10.2017 of Shri S.P. Beck, JS(Admin) on Points 1 to 3 and also furnished the information on Point 4 of the RTI application. The appellant might have received the letter dated 05.10.2017 of CPIO, RTI Cell. However, a copy of the same along with its enclosures is enclosed herewith.

4. On further perusal of the reply of the JS(Admin) and CPIO, RTI Cell, it is observed that point-wise factual information has been provided by them, therefore, no further action is required on the part of FAA, in the matter.

5. The appeal is, therefore, disposed off accordingly.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
