**Brief facts of the case:-**

In the appeal, the appellant has stated that she has sent an application dated 31.07.2017 to the PIO of the Chief Information Commissioner under Section 6 of the RTI Act, 2005. But she has not received reply from the PIO even after laps of statutory period of 30 days and requested to direct the PIO to supply complete detail and factual information at the earliest.

**Decision with reasons:-**

2. The matter was enquired from the CPIO, RTI Cell who intimated that no application dated 03.10.2017 under Section-6(1) of the RTI Act has been received from the appellant. Further, on perusal of the copy of the application dated 03.10.2017 enclosed by the appellant with the appeal, it is observed that the appellant through the said application has requested for personal re-hearing of her second appeal No.CIC/ARMY/A/2017/179375/SD and not sought information under Section-6(1) of the RTI Act. Hence, the appellant is advised to file RTI application under Section 6(1), which should be accompanied by a fee of rupees ten as per RTI Rules, 2012.


