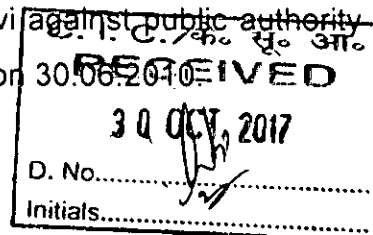
Brief facts of the case:-

In the RTI application, the appellant has sought 12 points information regarding registration number and present status of appeals u/s 19(3) and complaints u/s (18) filed by him in the Commission during the year 2010, 2011, 2013 and 2016.

4. In the appeal, the appellant has stated that incomplete/partial information without desired registration number and present status of more than four years long pending complaints against non-compliance of CIC decisions in respect of Points-1 to 5(B), 6(b), 10 & 12 and no information in respect to Point 6(a), 7,8,9 & 11(a-b) of the RTI application and requested to direct the concerned CPIOs to provide the complete requisite information in respect of Points 1 to 12.

Decision with reasons:-

4. Regarding Point-1(a) of the RTI application, it has been observed from the perusal of the AppsCom software that the case file No.CIC/LS/A/2010/001193 pertains to the appellant Shri Anmol Ganpat Rackvi against public authority 'CBDT' and the appeal was dismissed by the Commission on 30.06.2010.



5. On Point-1(b) of the RTI application, the appellant has sought action taken by CIC after issuing Show Cause Notice u/s 20(1) to the Director(LS) & PIO, DDA in case File No.CIC/LS/A/2009/001193. Since the public authority is presently entrusted to the registry of IC(YA), direction is accordingly given to Shri R.P. Grover, DO to IC(YA) cum CPIO to provide present status of the above mentioned case, if available to the appellant within 4 weeks from the date of receipt of the order. Since the matter is very old, CPIO may also take the assistance of JS(MR) for retrieving digital case files.

6. Points 2 to 5 of the RTI application are concerning to the public authority "Ministry of External Affairs", direction in this regard is given to Shri S.C. Sharma, DO to CIC(RK) cum CPIO to provide status of the cases mentioned on these points, if available to the appellant within 4 weeks from the date of receipt of the order. A copy of RTI application and copy of reply dated 18.09.2017 of CPIO, Dak Section are enclosed for ready reference. Since the matter is very old, CPIO may also take the assistance of JS(MR) for retrieving digital case files.

7. Points 6(a-b), 10 & 12 of the RTI application are concerning to the public authority Ministry of Human Resource Development, direction is accordingly given to Shri R.L. Gupta, DO to IC(MP) cum CPIO to provide status of the cases mentioned on these points, if available to the appellant within 4 weeks from the date of receipt of the order. A copy of RTI application and copy of reply dated 18.09.2017 of CPIO, Dak Section are enclosed for ready reference. Since the matter is very old, CPIO may also take the assistance of JS(MR) for retrieving digital case files.

8. On points 7 to 9 of the RTI application, the public authority is DDA under Ministry of Urban Development, which is under the registry of IC(YA), direction in this regard is also given to Shri R.P. Grover, DO to IC(YA) cum CPIO to provide present status of the cases mentioned on these points, if available to the appellant within 4 weeks from the date of receipt of the order. Since the matter is very old, CPIO may also take the assistance of JS(MR) for retrieving digital case file. A copy of RTI application and copy of reply dated 18.09.2017 of CPIO, Dak Section are enclosed for ready reference.


9. On point 11(a-b) of the RTI application, Shri R.P. Grover, DO to IC(YA) cum CPIO vide letter No.CICOM/R/2017/01085 dated 06.10.2017 has furnished the information to the appellant. A copy of the same is enclosed.

10. *The four weeks period is being given to the CPIOs for compliance because the Commission is under process of shifting to its new location at Baba Gang Nath Marg, Munika.*

11. The appeal is, therefore, disposed off accordingly.

12. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.


