Appellant was present. Shri H.P. Sen, DO to IC(DP) cum CPIO was also present during the hearing.

Brief facts of the case:-

In the RTI application, appellant has sought inspection of case File Nos.CIC/YA/C/2016/900157, CIC/YA/C/2016/900180 and CIC/YA/C/2016/000043. Shri H.P. Sen, DO to IC(DP) offered inspection to the appellant. After inspection of all three case files, appellant has filed online first appeal in which he mentioned that the case files were not page numbered and alleged that few documents from all these three files are either missing or have been destroyed as these were not available in the files on the day of inspection.

Decision with reasons:-

- 2. During the hearing, appellant reiterated the contents of the appeal.
- 3. Shri H.P. Sen, DO to IC(DP) cum CPIO has intimated during the hearing that he produced the three case files for inspection to the appellant as received by him from the registry of the IC(SB). So he do not know whether any document is missing from the said three case files or not.
- 4. In view of the above, direction is given to Shri H.P. Sen, DO to IC(DP) cum CPIO to:-
- (a) confirm from DR of the registry from where he has received the said three case files that whether any paper concerning these case files are available or not within 5 working days from the date of receipt of this order.

- (b) If any paper is available concerning to any of these three case files, place it in the concerned case file.
- (c) Get the page number done of these three case files.
- (d) Thereafter, offer inspection to the appellant with mutual convenient date and time.
- 5. The appeal is, therefore, disposed off.
- 6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the CIC in Room No.185, Ground Floor, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066 against this order within 90 days.
