Brief facts of the case:-

In the RTI application, appellant has sought following information in respect of case file No.CIC/MORLY/A/2016/303960-AB:-

- "A-1) soft copy of the Order of Mr. Amitava Bhatacharyya may please be supplied over email schokhi@chokhi.com
- A-2) date of the Order of Mr. Amitava Bhattacharyya
- A-3) date when the Order has been uploaded on CIC website
- A-4) date of Service to the opposite Parties including Foreign 3rd party mentioned on page 4 of Order by CIC/CPLO, Railways
- A-5) copy of communication sent to the Foreign 3rd Party by CIC/CPLO, Railways
- A-6) copy of chapter & verse of the RTI Act empowering CIC to suo-moto hear a Foreign Party, who is neither subject to the jurisdiction of the Hon'ble Supreme Court of India nor amenable to the Indian Evidence Act and/or the Constitution of India, in 2nd Appeal Proceedings inspite that the CPIO, Railways Public Authority at original stage and even FAA have not even adverted to this foreign 3rd party."
- Shri A.K. Talpatra, CPIO cum DO to Chief IC(RK) vide reply dated 20.12.2017 has 2. responded as under:-
 - "Point A1:- Visit CIC website & download the order.
 - Point A2 to A4:- Office copy of the order indicating the date of issue is enclosed. The order was uploaded on CIC website on 08.11.2017.

Decision with reasons:-
