**Brief facts of the case:-**

In the RTI application, appellant has sought following information:-

"(A) (1) Please confirm that under continuity of support to Hon'ble Supreme Court for tampering with Court Record by not providing proper reply there against Appeal No.CCI/SCOFI/A/2017/101192 has been disposed off on 22.11.2017 by fraudulently recording Appellant's absence for concealing to record Appellant's non-participation against improper disposal reported under letter dated 13.11.2017 (served on 14.11.2017). copy of which is placed below vide Annex-1.

(2) Kindly confirm that Appeal No.CIC/SCOFI/A/2017/132875 has been disposed off on 22.01.2017 on fraudulently recording Appellant's absence for concealing to record appellant's non-participation against improper disposal reported under letter dated 13.11.2017 (served on 14.11.2017) detailing thereunder concealed grounds under which appeals were being improperly disposed off as well as synopsis of the case proving that apprehension on present improper disposal was correct. The copy of said letter dated 13.11.17 is placed below vide Annex-2.

(3) Kindly confirm Appeal under Dak Receipt No.119146 Dt. 23.03.17, copy of which is placed below vide Annex-3, stands filed undisposed off because Appeal No.CIC/SCOFI/A/2017/132875 dt. 17.05.2017 stands disposed off on 22.11.2017."

(B) Kindly record information sought in verbatim, without making any change, under reply to present RTI application.

(C) Kindly provide proper reply on invoking Section 5(4) & (5) – RTI Act, if required."

2. Shri S.C. Sharma, CPIO cum DO to Chief IC(RK) vide reply dated 20.12.2017 has stated as under:-

"Point No.1&2. In respect of point No.1&2, it is to intimate that interpretation of decisions is not within the jurisdiction of the CPIO and hence no information on these points could be provided.

Point No.3 In respect of point No.3, it is to intimate that since the document with dak receipt No. 119146 dated 23.03.2017 was not received in this Registry, therefore, assistance under the provisions of the RTI Act, was obtained from the CPIO, Dak Section. The reply of the CPIO Dak Section is enclosed."


**Decision with reasons:-**

3. On perusal of the RTI application, reply of the CPIO and appeal, it is observed that point-wise reply furnished by the CPIO is seems to be appropriate, therefore, no intervention is required on the part of the FAA.
