## Brief facts of the case:-

In the RTI application, the appellant has sought certified copy of the judgement pronounced in case File No.CIC/CC/C/2014/00415-YA registered on 09.12.2014.

2. Shri R.P. Grover, CPIO cum DO to IC(YA) vide letter dated 22.12.2017 responded that:-
