## Brief facts of the case:-

The appellant has filed RTI application in DoPT who transferred the RTI application u/s 6(3) to CIC in which the appellant has sought following information -

- "1. Please provide the documents duly attested by PIO regarding for not signed the order No.CIC/PRSEC/A/2017/134027 dated 22.11.2017 (copy enclosed) by Shri Radha Krishna Mathur, Chief Information Commissioner with blue pen or blue ink pen and same are not issued to me
- 2 Please provide the documents duly attested by PIO with name and designation regarding names of CPIOs was not mentioned in place of respondent by Shri Radha Krishna Mathur in Order No CIC/PRSEC/A/2017/134027 dated 22.11.2017 (copy enclosed) and Shri Radha Krishna Mathur had been appointed by Ministry of Personnel Public Grievances and pension.
- 3. Please provide the documents duly attested by PIO with name and designation regarding Central Public Information Officer had not been mentioned in the Order No CIC/PRSEC/A/2017/134027 dated 22.11 2017 by Shri Radha Krishna Mathur CIC, New Delhi for claim of Rs.25000/- under the RTI Act 2005.
- 4 Please provide the documents duly attested by PIO with name and designation regarding name of CPIO of President of India under the RTI Act 2005
- 5. Please provide the documents duly attested by PIO with name and designation regarding Shri Radha Krishna Mathur is capable or not for the Chief Information Commissioner appointed by Ministry of Personnel, Public Grievances and Pension in connection with various orders issued by the Chief Information Commissioner outside the purview of RTI Act 2005

- 6. Please provide the documents regarding appointment of Shri SC Sharma, Dy. Registrar who had been signed order as part of commission and there is provision in RTI Act 2005 only eleven commissioners including chief information commissioner are the part of the commission not Shri SC Sharma, Dy.Registrar.
  - 7. Please provide the documents regarding actual PIO for the Order No.CIC/PRSEC/A/2017/134027 dated 22.11.2017 duly attested by PIO with name and designation."
- 2. Shri S.C. Sharma, DO to Chief IC(RK) cum CPIO vide his letter dated 05.01.2018 has responded as under:-
  - "1 The information does not fall under section 2(f) of the RTI Act, 2005 and hence the information cannot be provided.
  - 2,3,47&8 A copy of attendance sheet is enclosed.
  - 586 Transferred to CPIO, Administration Section of CIC for replying you directly."
- 3. Mrs. Savita Taluja, CPIO & SO(Admn) vide her letter dated 10.01.2018 has stated as under:-
  - "5 This does not pertain to Admin Section. This point was transferred to RTI Cell.
  - As mandated in section 5 of the RTI Act, 2005, Shri S.C. Sharma, Dy. Registrar has been designated as CPIO as per order No.3/3/2008/Admn/CIC dated 14.03.2017(copy enclosed)."
- 4. The appellant has filed his first appeal in DoPT who transferred the same to CIC. On perusal of the appeal, it appears that the appellant is aggrieved with non-receipt of information from the CPIO. DoPT. Since the DoPT has transferred the RTI application and first appeal to CIC, the appeal has been admitted.

## Decision with reasons:-

5. In the appeal, appellant has stated that CPIO has not provided information and penalty may be imposed on him/her for non-supply of information. However, on perusal of the case file, it is observed that Shri S.C. Sharma, DO to Chief IC(RK) & CPIO and Mrs. Savita Taluja, CPIO & SO(Admn) have already furnished information to the appellant as per Para-2 & 3 above (copy enclosed). The information furnished by both the CPIOs are seems to be appropriate except on Point-5, which has been transferred to CPIO, RTI Cell but no information has been provided. In this regard, CPIO, RTI Cell has been called for who intimated that information on the same query has already been furnished by Shri S.C. Sharma, CPIO & DO to Chief IC(RK) on the other RTI application dated 06.12.2017 of the appellant in which CPIO stated that "The information does not fall under section 2(f) of the RTI Act, 2005 and hence the information cannot be provided."

- 6 In view of the above, the appeal is disposed off.
- In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Municka, New Delhi-110067 against this order within 90 days.


