Brief facts of the case:-

2. Certified copies of all letters/communications issue by O/o the CIC with regard to showcause notice addressed to the CPIO, Ministry of Law & Justice, Department of Legal Affairs on the above reference cited.

3. Certified copies of entire note file/correspondence held by the CIC on the above reference cited."

2. Shri S.C. Sharma, CPIO cum DO to Chief IC(RK) vide letter dated 09.02.2018 has stated as under:-

"1. No separate show cause notice was issued except as mentioned in the decision at Para 11 (c).

2. As above.

3. No information is available. Response received on 07.02.2018, in compliance to CIC order 05.01.2018 is being put up the Hon'ble Chief Information Commissioner. However, a copy of the same is enclosed for your reference."


Decision with reasons:-
