**Brief facts of the case:-**

In the RTI application, the appellant has sought following information in respect of his application dated 08.09.2017 relating to case No.CIC/RK/C/2016/000019-AB decided on 02.08.2017:-

*"Action taken report in my application along with complete paper book of my application dated 08.09.2017."*

2. In response to RTI application, Shri A.K. Talapatra, CPIO & DO to IC(AB) replied as under:-

*"With reference to the RTI Application dated 20.01.2018 received in the registry vide diary number 105596 on 31.01.2018, it is to inform you that a reminder dated 20.09.2017 (copy enclosed) was issued in respect of your letter dated 08.09.2017 and compliance dated 11.10.2017 (copy enclosed) as received is provided."*

3. In the appeal, the appellant has alleged that the information supplied is not the information sought by the appellant. The respondent has failed to establish any reason as to why the actual information sought by the appellant has not been supplied to the appellant, therefore request to direct the CPIO to provide the actual information in the form of certified copies along with compensation as prescribed under the act.


**Decision with reasons:-**

4. To know the facts, case File No.CIC/RK/C/2016/000019-AB was called for. On perusal of the application dated 08.09.2017 available in the said case file, it is observed that the appellant has filed the application against the order of the Commission and not against the non-compliance by the respondent CPIO as no direction was given to the respondent CPIO in the order. **Direction is accordingly given to Shri A.K. Talapatra, CPIO & DO to IC(AB) to re-visit the matter and provide suitable information to the appellant within 2 weeks from the date of receipt of the order.**

5. The appeal is, therefore, disposed off.

6. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
