## Brief facts of the case:-

In the RTI application, the appellant has sought following information in respect of Commission's decision No.CIC/VS/C/2017/000236-AB dated 28.12.2017:-

"In reference to above quoted CIC penalty order/File CIC/VS/C/2017/000236-AB Dated 28.12.2017, I requested for modification of order in connection with the addresses of C.P.I.O., P.I.O. & General Managers through my letter dated 07.01.2018 [Annexure No.02], so that penalty order may be correctly implemented against C.P.I.O & P.I.O.

Kindly provide the copy of corrected order of above CIC Order dated 28.12.2017 [Annexure No.01] in regarding addresses of C.P.I.O, P.I.O. & General Managers as per R.T.I. Act.2005."

2. Shri A.K. Talpatara, CPIO & DO to IC(AB) vide letter dated 27.02.2018 provided the copy of corrigendum dated 25.02.2018.

## Decision with reasons:-

In the appeal, the appellant has stated that CPIO has provided only corrigendum of addresses of C.P.I.O., P.I.O. but no corrigendum in the text of the order as there is also transcription in the text of CIC order. The appellant has provided a copy of the Commission's order highlighting the text to be corrected. A copy of the order highlighting text as provided by the appellant is forwarded to Shri A.K. Talpatara, CPIO & DO to IC(AB) for doing the needful, as deemed fit.

- 4. The appeal is, therefore, disposed of.
- 5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
