Brief facts of the case:-

In the RTI application, the appellant has sought 3 points information in respect of a letter dated 12.10.2016 (Dy.No.180078 dated 19.10.2016) filed by the appellant in connection with non-compliance of Commission's decision No.CIC/BS/A/2015/000952 dated 19.07.2016.

2. Shri T.K. Mohapatra, CPIO & DO to IC(SA) vide reply dated 27.02.2018 responded as under:-

- "a) There is no such chronological arrangement on the disposal of Non Compliance matters.*
- b) Assistance was taken from the Dak Section, CR-II and CR-1 of this Commission based on the information received from them and also the information available on the website of the Commission the information on the action taken on your letters is as under:-*
- i) Letter dated 12-10-2016 having Diary no.180078 dated 19-10-2016 – this dak has attached electronically by compliance cell in the e-book of the case file no.CIC/BS/A/2015/000952.*
- ii) e-mail dated 02-01-2017 is not available.*
- iii) Letter dated 08-07-2017 having Diary no.147779 dated 12-07-2017 – this dak has attached electronically by compliance cell in the e-book of the case file no.CIC/BS/A/2015/000952.*
- c) No such reply is available in the e-book of the concerned case file no.CIC/BS/A/2015/000952."*


Decision with reasons:-

3. On perusal of the RTI application, reply of the CPIO and appeal, it is observed that the CPIO has provided only the present status of the non-compliance letter dated 12.10.2016 (Dy.No.180078 dated 19.10.2016) and its 4 reminders but he has not provided information on the action taken on the said non-compliance letter. As per appeal, the appellant is mainly aggrieved that his above said non-compliance letter has not been decided since long. In this regard, **Shri T.K. Mohapatra, CPIO & DO to IC(SA)** is directed to provide information on action taken on the non-compliance letter dated 12.10.2016 to the appellant within 5 working days from the date of receipt of the order.

4. The appeal is, therefore, disposed off.

5. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
