**Brief facts of the case:-**

In the RTI application, the appellant has stated as under:-

*"I have filed two non-complaints against CPIO JK Goel, AAI, New Delhi and Harbir Singh CPIO NSCBI Airport Kolkata (Details given below). It has been years and no information has been provided till date.*

- 1) *Ramji Singh Vs Harbir Singh CPIO AAI, NSCBI Airport, Kolkata:- Non-Complaint Application dated 14.12.2016 and submitted at Central Information Commission on 19.12.2016. **Diary No.192162.***
- 2) *Ramji Singh Vs J.K. Goel, Rajiv Gandhi, Safdarjung Enclave, New Delhi:- Non-Complaint Application dated 14.12.2016 and submitted at Central Information Commission on 19.12.2016. **Diary No.192165.***

*Kindly note that am a retired professional and it is really difficult at this age to invest so much time in following up. Thus, requesting you to kindly take immediate hearing on above matter on immediate basis.*

*Also kindly revert me with the hearing date"*

Shri A.K. Talapatra, CPIO cum DR to IC(AB) vide reply dated 02.04.2017 responded as under:-

**"Point no.1)** – Your diary number 192162 relates to the file number CIC/YA/A/2015/000234. It is to inform you that the information sought by you pertains to old records and the cases of Airport Authority of India was allocated to this registry in first week of February 2018, a fresh reminder dated 27.02.2018 (copy enclosed) was issued to the concerned CPIO for providing a compliance report.

**Point no.2)** – Your diary number 192165 relates to the file number CIC/YA/A/2014/003445. It is to inform you that the information sought by you pertains to old

records and the cases of Airport Authority of India was allocated to this registry in first week of February 2018, a fresh reminder dated 27.02.2018 (copy enclosed) was issued to the concerned CPIO for providing a compliance report.

Further necessary action as deemed fit would be taken on the receipt of compliance report."

In the appeal, the appellant has stated that instead of providing him the details of case hearing of the above mentioned cases, the CPIO has given other irrelevant information which was not sought by the appellant. The appellant requested to direct the CPIO to take immediate hearing of the above mentioned cases and intimate about the hearing date.

**Decision with reasons:-**

2. Although the reply of the CPIO is technically correct but not appropriate. The appellant wants to know the date of hearing of his two non-compliance cases mentioned above. Direction is accordingly given to Shri A.K. Talapatra, CPIO cum DR to IC(AB) to re-visit the matter and provide suitable information to the appellant within 1 week from the date of receipt of the order.

3. The appeal is, therefore, disposed off accordingly.

4. In case the appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi-110067 against this order within 90 days.
