*How much will be prescribes times for the hearing? After the dak entry by CIC of India? And after the hearing said matter complete the procedure, how much prescribes times for it?....."*

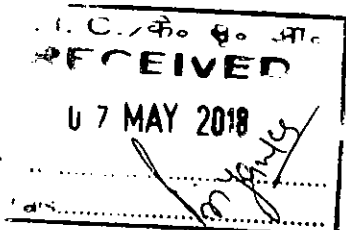
Shri S.S. Rohilla, CPIO cum DO to IC(SB) vide reply dated 11.04.2018 responded as under:-

*"No time period has been prescribed for deciding the Second Appeal/Complaint in the Commission."*

In the appeal, the appellant reiterated the same and has not mentioned as to why he is aggrieved with the reply of the CPIO.

**Decision with reasons:-**

2. In view of the above, it is observed that the reply furnished by the CPIO is appropriate, therefore, no intervention is required on the part of the FAA.




